*Annex No 1***Plan of the actions to be taken by the subcontractor's driver in the event of an accident, incident, emergency or fire**

<b>In the event of an accident, incident or emergency during the transportation, crew members of the vehicle carrying the cargo shall take the following actions when it is safe and possible to do so:</b>	
1	Apply the braking system, turn off the engine and disconnect the battery at the main switch, if any;
2	Avoid ignition sources, namely, not to smoke, not to use e-cigarettes or similar items, not to switch on any electrical equipment;
3	Inform the relevant emergency services and provide as much information as possible about the event or accident and the materials transported (tel. 112 in Lithuania or abroad);
4	Put on a warning vest and appropriately place warning signs;
5	Prepare transport documents for the arriving rescuers;
6	Not to walk on the scattered materials, not to touch them and to stand in a place protected from wind, not to inhale any smoke, soot, dust or vapor;
7	If necessary and safe, to use fire extinguishers for small or initial fires in tyres, brakes and engine compartments;
8	Vehicle crew members should not extinguish a fire in the cargo compartments;
9	If necessary and safe, to use equipment available in the vehicle to prevent leakage of the substance into the aquatic environment or drainage system and to prevent the spread of diffused substances;
10	Stay away from the site of the accident or incident, advise others to stay away and follow the advice of the emergency services;
11	Remove any contaminated clothing and protective equipment used and safely arrange them.
